Sub:- Extension of cut-off date of admissions of students in the Ayurveda, Unani, Siddha and Homoeopathy (ASU&H) Medical Colleges granted permission by the Central Government in the academic session 2017-18 - reg.

Sir/Madam,

In continuation to the Ministry of AYUSH earlier letter No.R.11011/01/2016-EP(IM-1) dated 14.09.2017 and No.R.11011/04/2016-EP(IM-1) dated 27.10.2017, extending the cut-off date for UG & PG courses ASU&H colleges for the academic year 2017-18, it has further been decided to extend the cut-off date to 22nd November, 2017 because of administrative reasons.

2. This instruction is issued as a one-time measure for the academic session 2017-18 only. All consequent admissions in the extended period by the concerned Universities and authorities involved in admission process for the academic session 2017-18 will be at par with those done before 8th November, 2017.

3. The Central Council of Indian Medicine and Central Council of Homoeopathy are hereby requested to notify immediately the extension of the cut-off date of admissions as above and circulate it to all concerned Colleges, Universities and State Governments. It may also be placed on the Council's website for wider publicity.
