EMPANELMENT OF ADVOCATES

Last date for submission of application is: 30.07.2018

C.C.H is a statutory body of the Ministry of AYUSH Government of India. It proposes to make Panel of Counsels to represent the C.C.H. before various High courts/Supreme court/CAT etc.

The practicing advocates who are registered with Bar Council of India/State Bar Council are eligible for empanelment. The qualification, experience, schedule of fees, other terms and conditions and the application format in which the application is to be submitted, have been prescribed.

The Advocates who are on the existing panel of C.C.H, shall cease to be on the panel of C.C.H after new panel is finalized against this notice. Therefore, they may also apply afresh in response to this notice.

Application should be submitted in the format prescribed in Annexure "A" enclosed herewith along with all supporting documents in a sealed envelope to Secretary, Central Council of Homoeopathy, 61-65, Institutional Area, Opp. D Block, Janakpuri, New Delhi-110058 in a sealed envelop by mentioning "Application for empanelment of Advocate".

Application for empanelment at CCH does not confer any right/assurance whatsoever, to an applicant that he/she will be empanelled on the panel of CCH. Letters to advocates confirming their empanelment will be issued by CCH separately.

GUIDELINES FOR EMPANELMENT OF ADVOCATES

Following guidelines are designed to provide and regulate the manner and procedure for empanelling the advocates to represent and assist CCH before various courts and for regulating the referrals of the cases and payment of fee/remuneration. These guidelines shall supersede all existing instructions in this regard, if any and is subject to change without assigning any reason.

1. Eligibility of Empanelment

The applicant has the valid registration with Bar Council of India / State Bar Council and must have at least 10 years standing experience of handling court cases of State Govt. / Central Govt. / PSU /Autonomous bodies in High Court / Supreme Court of India.

2. Tenure of Empanelment

The initial empanelment will be for the period of 05 years. Performance of empanelled advocates shall be reviewed at regular interval for continuance of their name in the panel.

3. Payment of Fee and Other Conditions

The fee shall be such as may be decided by the Law Ministry from time to time. No advance fee shall be paid. It will be the responsibility the advocate (to whom any case is assigned) to submit the certified copy of the judgment so that full and final payment is made.

4. Removal from Panel

Empanelment shall be liable to be cancelled due to occurring of any of the following disablements on the part of the Advocate.

- a. Giving false information in the application for empanelment.
- b. Failing to attend the hearing of the case without any sufficient reason and / or prior information.
- c. Not acting as per CCH's instructions or going against specific instructions:
- d. Threatening, intimidating or abusing any of the CCH's employees, officers, or representatives :
- e. Passing on information relating to CCH's case on to the opposite parties or their advocates or any third party which is likely to cause any damage to the CCH's interest :
- f. Giving false or misleading information to the CCH relating to the proceedings of the case
- g. Seeking frequent adjournments or not objecting the adjournment moved by other party without sufficient reason.
- h. Frequent absence from the court proceedings even if 'pass over' or 'proxy' is obtained by an advocate.
